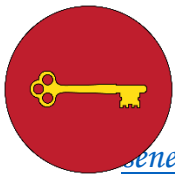
I recommend again that all members of the Barony update their mailing address with Milpitas so there will be no delay in receiving your polling letter when the time comes.

From the Desk of the Baronial Exchequer

Report from the Baronial Exchequer – 7-21-2019.

As of this date, the Baronial Checking Account contains \$5,109.64; the WoW Wall Designated fund contains \$577.61 (included in the baronial total).

The site fee check for HMBB & I in March 2020 has cleared as of 6/19/2019,

At Warriors Games we wrote checks for \$40 each for site rental for the American Legion Hall in Harleysville SC for the August 17 and October 5, 2019 Baronial Commons meetings / Wall Painting.

At this meeting, we must write checks for: \$50 for SCA, Inc. Insurance Certificate for Crown Tourney; \$570 for Bluebird Property LLC for the site fee for Silver Chalice; and for \$531.22 to Robert Himmelsbach for purchase of Canvas, Tape and Ropes for the WoW Wall Project.

We must also pay an additional \$540.00 for the rental of the baronial storage facility, upon receipt of invoice or receipt.

This will leave the Baronial Account with \$3,338.42 and the WoW Wall Designated Fund with \$46.39. We will need to either raise, or appropriate from the General Funds a minimum of \$411.26 (not counting shipping costs) to purchase the remainder of the materials to construct the wall.

We anticipate retrieving \$150 of the site cost for Silver Chalice as a refundable deposit.

The Quarterly Report for the second quarter of 2019 is in process and will be sent to the Seneschal for signature as soon as possible.

We must make arrangements for the Seneschals, Ingvar Earlingson and Patris de Terra Lepori, to become signatories on the Account as soon as possible. Please see me after the meeting to schedule how and when.

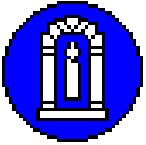

Baronial Commons Business Meeting

Meeting was held on July 21, 2019 at Geoffrey d'Ayr's home in Charleston, SC. Those in attendance are as follows: Geoffrey d'Ayr "Bish", Invar Earlingson, Alison MacCoul "Bambi", Seifrid Wolfehart, Yvonne Montclair, Slaine inghean ui Sheachnasaigh, Patris de Terra Lepori, Aodh "Adendra" Marland, Thylacinus Aquila of Dair Eidand, Anna of Dair Eidand, Roibeard Mac Oscar, William "Abbott" Costello, Jorunn nic Lochlainn (via telephone) and Qulan Chaghan.

Upon opening the meeting the officers reported as followed:

Baronage: Members need to vote on and approve the payment for the storage facility of the Barony's equipment. The total rental fee through the end of the current baronage is \$540. A motion was brought forth, seconded and passes to pay the rental fee's through the end of this baronages reign which is to end in March 2020.

Herald: Patris notified everyone that his warrant expires in November 2019. He will renew it and pending conversation with the Baronage will stay on as Baronial Harold through the end of their reign but looks to step down at that time.

Marshall: Baronial Marshal (Hrothgar Ravensson) was not in attendance so Seifrid presented an update for the Marshall office. Several fighters have stepped forward and are working to complete their Marshalling warrants. He currently is an MIT and will be completing the requirements as soon as possible. Several fighters are also regularly getting together to make armor, discuss fighting techniques and advise new fighters interested in getting into the Heavy aspect of fighting.

Arts and Sciences: Baronial A&S officer (Esme Bramley) was not in attendance but had sent her report in prior to the meeting. Here in is her report: A&S is progressing beautifully! We, of course, had the awesome shoe making class with Mistress Michel We had 13 in attendance and nearly everyone went home with their shoes complete - including Her Excellency! If there is more interest, in another month or two, after the hustle and bustle of the fall season, we can explore having Michel return for another go-round. She's already said she wouldn't mind that at all :)

As we have all been seeing, Mistress Jorunn has been doing phenomenal work with the people, new and old, in her Hospitality Hall. I haven't heard much from anyone else about their A&S workings, but I'd like to see that changed. Just a heads up, once in a while, so I can show how much amazing work our people are doing. That would be amazing!

I am also exploring having Lady Ellisif, of Nottinghill Coill, come out for a T-Tunic 2.0 - making fitted tunics that look like other periods, in basic shapes that everyone - MALE AND FEMALE - can make use of! With how many gentlemen we now have, I think it's important that we all make everyone look their absolute best.

Chronichler: Qulan gave notice of resignation as Chronichler as she wishes to move to the Baronial MOL position. William "Abbott" Costello offered to step up as Chronichler in her place. A vote was placed, seconded and passed by all members in attendance to allow Abbott to take over the Baronial Chronichler position. Qulan will complete the August edition and then pass the information of office to him.

Chatelaine: Slaine reported there is a demonstration coming up in November. We have Hospitality Hall happening on Wednesday nights in Tear Seas Shore and many new people who have joined in Moorhaven.

MOL: Qulan asked to become the new Baronial MOL. To do this she will step down as TSS MOL and asked to step down from Baronial Chronichler to which William Costello had already been voted into place. A vote was called to order, seconded and passed by the members present at the meeting to allow Qulan to become the Baronial MOL.

Web Minister and Clerk Signet: The Baronial Web minister and Clerk Signet (Umm Samin bint Asad al-Isfahaniyya) was not in attendance. Qulan gave notice Umm Samin was moving back into our Barony and for now all the backlog scrolls were caught up.

Canton Reports:

Tear Seas Shore: Alison "Bambi" MacCoul gave report. Quarterly reports are done, Mannonan Mac Lir event has been spiked, and she will be heading to Pennsic at the end of the month. As seneschal, if anyone needed to get in touch with her the land line was not working well and was advised to use her cell number.

Moorhaven: Patris de Terra Lepori gave report. They are experiencing a large amount of growth so their monthly meeting place has been changed to the Grumpy Monk. It is a pub in Myrtle Beach that has a back room they can use and provides a more public setting for their members to be able to invite new comers into the group.

Misty Marsh: not in attendance but seneschal's report has been filed.

Old Business:

Silver Chalice: Esme sent in a report of the progress so far: We are seeing motion! I was finally able to get the contract set for the site and sent it down to Geoffrey d'Ayr. Slaine has graciously accepted to be my deputy for Silver Chalice, since she's been with me each step of securing this site. We discussed the budget that Geoffrey worked up, and both thought it looked good. I discussed the minor change of moving the admittance cost from \$10 to \$12 to mitigate any possibility of the Barony *losing* money on this venture...especially considering how long it's taken to get off the ground. (at this point a minor discussion took place with the members present and it was decided and voted upon to spit the difference and charge \$11) The current cost is set, pending the acquiescence of the financial committee, and includes TWO PORTA-POTTIES (there is ONE flushing toilet on sight) as well as, I do believe - Slaine can correct me if I am wrong - the availability of showers for fighters, off the side of the field. I know nothing more of the showers, other than that they were mentioned ...whether they have hot water? GOOD QUESTION! The only restrictions to this site, right now, are be kind to the neighbors who live nearby, don't let dogs off leash (they WILL be shot by property owners if they mess with the local hobby farmer's stock), and no cannon fire... I think that's pretty reasonable, no? As of NOW I am looking for persons to Marshal, to Run A&S, and I am praying that Three Barons will be our chefs for this event. They know the site, they know its issues and there's tons of spigots for running water. If you want to run a Tournament, or Host A&S, or host a class... MESSAGE ME!

Fall Crown Tourney: The autocrat, Alisoun MacCoul, reported on this. Facebook and the Webpage are both now available web resources for the event. Pay Pal is still not working yet but will be very shortly. The site tokens are beautiful. There are three possible A&S competitions so may need local help to run them. Feast is still in research but will be of German origins and influence. Youth combat tournament may be managed by the Barony unless Kingdom says otherwise. Please review the webpage. If you find errors please let Alisoun know. **Fall Crown Tourney (continued):** She is currently putting together a team to decorate. Will need a planning list completed by the August Business meeting.

WotW Walls: Seifrid reported on this. We have some of the materials, the canvas and ropes which will be the first section of the project. We will be meeting at the American Legion Hall on August 17th at 11:00 am to cut, sew and assemble the panels. The painting and art is tentatively planned to happen at the second meeting when images of what will be painted can be decided upon. Anyone who wishes to submit a drawing for one of the panels needs to send an 8x10 copy of the image to Seifrid to put into the report for the Baronial Business meeting in August to be displayed to the barony and voted on what we can get done in time for WotW.

Feast of St. Paul: Patris gave report on this Moorhaven event. The event is still in the planning stages. Currently looking at having it at the Little River Elks Lodge as a day event. Tentatively they are considering holding it in February 2020.

HMBB: Alisoun at this time had been the temporary autocrat for the event. A call was made in the Mayhem for those interested to please contact the Baronial Seneschal but no one contacted Ingvar prior to the meeting today. Since no one had notified the Baronial Seneschal of their interest Seifrid asked if he could autocrat the event. The motion was brought to the floor, seconded and voted upon as Seifrid to become HMBB's autocrat with Alison as deputy to assist him if needed. The motion was passed by all members in attendance.

Trim: Alisoun reported that Calontir Trims would be selling at Crown Tourney. Discussions are still ongoing with his suppliers but hopes to get an answer by the time Pennsic is here.

New Business:

MD visit: Patris brought up a question to the members. Due to recent events and loss of life on the combat field he asked if members of our community would interested in having a class or information session provided by a licensed MD about heart attacks, stroke and other complications that some of our activities could exacerbate. The consensus was so positive, so Patris said he would get in contact with some of his colleagues and see what he could come up with.

Letter of Intent: This year will be an investiture as our Baron and Baroness step down from the office. For those interested, please start considering your letters of interest as they will need to be written and submitted within the window of requested time from the Crown.

With no further business to mention, the meeting was adjourned at 1605.

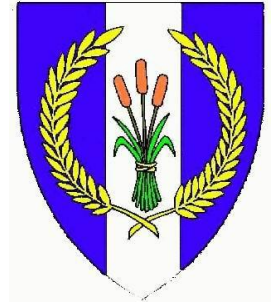
Skipping the November meeting
